# **TERMS OF USE**

#### AGREEMENT TO TERMS

These Terms of Use constitute a legally binding agreement made between you, whether personally or on behalf of an entity ("you") and Human Evolution for Landscape Protection, doing business as HELP ("HELP", "we", "us", or "our"), concerning your access to and use of the <a href="https://help-nonprofit.org">https://help-nonprofit.org</a> website as well as any other media form, media channel, mobile website or mobile application related, linked, or otherwise connected thereto (collectively, the "Site"). #### **Informal Negotiations**

#### **Binding Arbitration**

Any dispute arising from the relationships between the Parties to this contract shall be determined by one arbitrator who will be chosen in accordance with the Arbitration and Internal Rules of the European Court of Arbitration being part of the European Centre of Arbitration having its seat in Strasbourg, and which are in force at the time the application for arbitration is filed, and of which adoption of this clause constitutes acceptance. The seat of arbitration shall

be Turin, Italy. The language of the proceedings shall be Italian. Applicable rules of substantive law shall be the law of Italy.

#### Restrictions

The Parties agree that any arbitration shall be limited to the Dispute between the Parties individually. To the full extent permitted by law, (a) no arbitration shall be joined with any other proceeding; (b) there is no right or authority for any Dispute to be arbitrated on a class-action basis or to utilize class action procedures; and (c) there is no right or authority for any Dispute to be brought in a purported representative capacity on behalf of the general public or any other persons.

#### **Exceptions to Informal Negotiations and Arbitration**
